Introduction Simply Put

You + Me Shared Studio Inc. ("You + Me Studio") is committed to protecting your personal information and your privacy. We collect and process personal data about you to provide the services you use, operate our business, meet our contractual and legal obligations, protect the security of our systems and you. We collect and use your information only when necessary. Please read this document to find out more information.

Accountability and Recourse

You + Me Studio is responsible for your Personal Information, defined below, under its control. Collection of Personal Information

Personal information ("Personal Information") is information about you as an individual and includes information that identifies you and that can be used to contact you. This includes such information as your name, e-mail address, mailing address, telephone number, and the like. We also collect data about the frequency of your visits and other information that you have communicated with us, so that we may constantly strive to offer you the best range of services.

Simply Put

We have a Privacy Officer available to answer any questions you may have about our Privacy Policy.

Simply Put

We collect your Personal Information to enable us to contact you directly and process your booking of the studio.

We also note how often you book our Studio and any feedback you provide us in order to improve the services we offer.

Online and In Studio Purchases

If you use a credit card to pay and confirm your booking online at our website ("Website") or a debit or credit card at our studio our payment services provider, Square, collects your debit or credit card related information to process your payment.

When you complete the information request or booking request form on our Website, we collect your Personal Information to respond to your inquiry or contact you regarding your booking request. We also use your Personal Information to process your booking.

Aggregate Data

We may also combine your Personal Information with that of other individuals to create aggregate data which we will use to improve our services and develop new ones. Aggregate data is general information about groups of clients but not about you as an individual. We may also disclose aggregate client data which we may use in our internal research and to tailor our promotional offers. Your data will never be individually identified or identifiable in reports of the research findings; only aggregated data (group averages) will be presented.

Our Website

Online Registration

You do not need to register to visit and view our Website. However, to book our Studio you may be required to fill out an online booking form containing your Personal Information. We may also request other optional information when we confirm your booking, which you may choose not to provide. We use this information to identify who you are and to administer our services, including your purchases and participation in promotions and surveys.

Tracking

As is typical in many websites, we use automatic data collection technologies to track usage patterns on our Website. Each time you visit our Website, our server records your Internet service provider, IP address, the date and time of your visit, the pages you visit and the documents downloaded, the searches you performed, and the referring Uniform Resource Locator's (URL's) you came from. We use this information to optimize our Website service. We also use cookies to collect information about your visit to our Website.

Simply Put

We use a Third-Party service provider to process debit and credit card payments. They collect your debit or credit card information to process your payment.

The information you provide us when filling out the inquiry form or booking request form on our Website is used to answer any questions you have, contact you and process your booking.

Simply Put

To help create promotional offers and other marketing information we gather group data. Your information is not separately identified.

Simply Put

You do not have to register or create an account to use Website. A booking request form is available on our Website where some Personal Information is required to be entered.

Simply Put

To improve our Website service certain information about your use of our Website is tracked.

However, You + Me Studio is not responsible for, nor do we accept any liability for, the personal information collection, use and disclosure practices of other entities to which our Website may link. As a resource our Website contains links to Third-Party websites. You + Me Studio is not responsible if any of your Personal Information is collected when you use those links

Cookies

As you navigate through and interact with our Website, we use automatic data collection technologies, such as cookies and web beacons, to collect information about your equipment, browsing actions and patterns.

Cookies are small text files that are placed on your computer when you visit our Website. Cookies may automatically collect information such as an identifier assigned to your device, your Internet Protocol address (IP address), time spent on our Website, web pages or websites visited, browsing habits, and preferences.

We may use both session cookies and persistent cookies on our Website. A "session" cookie lasts for a single browser session only and is deleted when the user closes the web browser. A "persistent" cookie remains on the user's device (even while powered off) until it expires or is deleted.

Cookies and similar tools are used in the following ways on our Website:

- + We use cookies to remember your preferences, purchases and settings when you navigate through our Website.
- + We use cookies for security purposes.
- + We use web beacons in our email communications to determine whether an email we sent was opened and whether you clicked on any of the links within the email communication.
- + We use Squarespace to collect information about how you use our Website. Squarespace uses cookies to collect information such as how long you stay on our Website or specific pages of our Website, how you arrived at our Website, and the website you visited before or after visiting our Website. These cookies also help us identify unique visitors to our Website. We use this information to help us

Simply Put

To help us understand how you use our Website we collect certain data by sending out a cookie text file to your computer.

We may use two different types of cookies, "session" or "persistent". When you close your web browser the "session" cookie is deleted. The "persistent" cookie is there until it expires, or you delete it.

This is how cookies are used on our Website:

- + Remember what settings you prefer.
- + Security.
- + To know if you opened our email or link.
- + How you use our website.
- + To be able to display videos and know how they are viewed.
- + To support social media sharing functions.

- + We use cookies to facilitate the display of any video content on our Website. These cookies may collect information about how a video is played and information about the device used to access the video, such IP address, browser type, Internet Service Provider and operating system.
- + We use social media widgets and cookies to facilitate social sharing functionality on our Website. When you share information using a social media sharing button on our Website, the social network will record that you have done this and will use this information in accordance with its own privacy policy.

You may be able to control cookies using your browser settings. For example, you may be able to set your browser to block or delete cookies, or to notify you before a cookie is set. If you block cookies you may not be able to use all of the features of our Website. By continuing to use our Website without changing your browser settings, you consent to our use of cookies as described above.

If you block cookies you may not be able to use our Website fully. By using our Website you agree to our use of cookies.

Use and Disclosure of Personal Information

We will not use or disclose your Personal Information for any purpose other than those for which it was collected, except with your consent or authorized or required by law. You + Me Studio collects and uses your information for the following purposes:

- + to communicate with you by message, phone or email;
- + to determine your eligibility for receiving our services;
- + to provide you with a copy of your invoice and booking confirmation;
- to invite you to participate in client surveys or other opiniongathering devices that assist us in making our services more responsive to your needs;
- + to inform you of various matters relating to the services you have purchased or may be interested in;
- when in line with the preferences you have shared with us, to provide you with information or advertising relating to our services;
- + to conduct special promotions;
- + to screen our bookings for potential risk or fraud;
- + to protect against harm to the rights, property and safety of You + Me Studio, our employees, our clients and others.

Simply Put

Unless the law asks for it, or you give us permission to, we will not use of give out your Personal Information except for the reasons why we have it:

- + to contact and correspond with you regarding any inquires or booking related matters;
- + to process your booking and provide invoicing;
- + to ask for your feedback;
- + to send marketing and promotional materials if you agreed to receive it;
- + to protect against fraud and other possible harm.

We will retain your Personal Information only as long as necessary

Third-Party Service Providers

We may transfer (or otherwise make available) your Personal Information to affiliates or service providers that provide services on our behalf, such as processing payments, storing customer data, hosting our Website, analyzing our business, running our promotions, scheduling, marketing, and communicating with you. Your Personal Information will not be added to their mailing lists without your consent nor will they contact you in any manner except to provide services on our behalf.

We use Third-Party service providers to support our business and the services we provide you. They will only contact you on our behalf in support of those services unless you give them approval to do otherwise.

Consent

Your knowledge and consent are required for the collection, use, or disclosure of your Personal Information. When you access our Website or use any of our services either on our Website or at our Studio, you consent to the use of your Personal Information for the purposes listed above. You may refuse or withdraw your consent at any time; however, we may not then be able to provide you with our full range of services. We will advise you when you refuse or withdraw your consent of the impact that will have on what we are able to provide. For information on withdrawing your consent, please contact our Privacy Officer.

Simply Put

By using our Website or any of our services you are agreeing to the use of your Personal Information. You can decline or withdraw your consent, but you may not be able to use our services fully.

Accuracy

You + Me Studio will take reasonable efforts to ensure that your Personal Information is accurate, complete, and current as required for the purposes for which it was collected. If necessary, we will correct or amend your Personal Information if its accuracy is challenged and found to be deficient.
